## NFA Transfer and Sale Policy

**NFA Documentation is completed BY APPOINTMENT ONLY!**

### Customer to Customer NFA Transfer Documentation

- BigShots is happy to help create your Form 4 to transfer ownership.
- Both parties must be present and possess a valid Nebraska Driver's License with their correct physical address and the ATF Documentation (Approved Form 4) showing proof of ownership.
- Firearm must be present. Firearm must be bagged/cased/boxed and unloaded.
- Fee: Paperwork fee starts at \$100 for Individual, plus Fingerprint Cards and Photo charge. Trust/Corporation start at \$125.

### Incoming NFA Transfers from an FFL SOT Dealer

- Shipped transfers are only accepted from FFL SOT dealers.
- A transferred NFA Item must meet all requirements of Nebraska and Federal law and must be shipped with the following:
  - A copy of the transferor's FFL, SOT, and Approved ATF Form 3
  - Name and phone number of the customer who purchased and is receiving the firearm.
- NFA Items will only be transferred to the customer designated by the packing materials included with the shipment.
- We will contact the individual to make an appointment for documentation.
  - ***If you are awaiting an NFA transfer item, make sure your voicemail is set up and able to receive messages.***
- Customers will have **45 days (from contact)** to begin their NFA Paperwork.
- **After 45 days** a transfer will be considered **abandoned** and will be absorbed into store stock with no expectation of any further compensation to the customer.
- Fee: Paperwork fee starts at \$100 for Individual, plus Fingerprint charge and Photo charge. Trust/Corporation start at \$125.
- Please Note: It is the responsibility of the transferee to see that all shipments are insured sufficiently. BigShots accepts no responsibility for damage or loss for shipments that are inadequately insured.

## NFA Transfer and Sale Policy

### APPROVED NFA TAX STAMPS

- We will notify you by telephone when your NFA Item and Approved Tax Stamp is ready to be picked up.
- ***If you are awaiting a Tax Stamp, make sure your voicemail is set up and able to receive messages.***
- **Approved NFA Items must be picked up IMMEDIATELY**
  - Per the ATF Form 4, item 3. “**Approval of Application.** Upon approval of an application, the NFA Division will return the approved copy to the transferor for delivery with the firearm to the transferee. Since the approval of the application effectuates registration of the firearm to the transferee, the physical transfer of the firearm must be completed immediately; however, the transferor must not transfer the firearm until the application has been approved and received. If the physical transfer of the firearm cannot be completed immediately, the transferor must contact the NFA Division with the specifics.”
  - Further.... ATF Form 4, item 5: “**Cancellation of Approved Application.** The transferor (BIGSHOTS) may cancel an approved application only if the physical transfer of the firearm has not been completed. The transferor must return the approved application with the original tax stamp affixed with a written request for cancellation, citing the need and that the physical transfer of the firearm did not take place.”
- Approved NFA Items **NOT** picked up ***Immediately*** will be subject to withdrawal of the approved Tax Stamp and the item considered abandoned. There will be no refund.
