## Non NFA Transfer Policy

BigShots Indoor Range is happy to receive transfers for our customers. All transfers must be compliant with Federal and Nebraska law and comply with BigShots Store Policy

### Person-to-Person Transfer (Private Party Transfer)

- Both parties must be present and possess a valid Nebraska Driver's License with their correct physical address, Nebraska Concealed Handgun Permit and/or Nebraska Firearm Purchase Certificate
- Firearm must be present. Firearm must be bagged/cased/boxed and unloaded.

### Incoming Non-NFA Transfers from an FFL Dealer

- BigShots **will not** accept transfers from GrabAGun or Buds Gun Shops.
- **We will ONLY accept transfers for individuals OVER 21.**
- Shipped transfers are only accepted from FFL dealers. We no longer accept mailed transfers from individuals.
- If you purchase a firearm from another FFL, please have the other FFL email bigshotsrange@gmail.com with their FFL information if we are not currently already working with the other FFL.
- A transferred firearm must meet all requirements of Nebraska and Federal law and must be shipped with the following:
  - A copy of the transferor's FFL
  - Name and phone number of the customer who purchased and is receiving the firearm.
- Firearms will only be transferred to the customer designated by the packing materials included with the shipment.
- When your firearm is ready to be picked up you will receive a phone call informing you that your transfer is ready. If you are awaiting a transfer, make sure your voicemail is set up and able to receive messages. When the firearm arrives, it will be processed into our system, this means that while your tracking may say that the firearm has arrived at our facility it will not be ready until we call you.
- The customer is expected to pick up their transfer within 14 calendar days of being contacted.
  - After 14 calendar days, if the transfer has not been picked up the customer will be assessed a daily storage fee of \$10/day beginning on the 15th day.
  - Firearms received and not picked up within 45 days will be considered abandoned and sold to pay for storage and receiving fees. Excludes deployed military with prior arrangement!

## Non NFA Transfer Policy

### Outgoing Non-NFA Transfers from an FFL Dealer

- All outgoing transfers require a valid FFL copy from the dealer the firearm is being shipped to and well as a valid driver's license copy from the customer.
- Shipping cost are determined by value and shipping weight.
- Any firearms purchased at BigShots Indoor Range are exempt from the transfer fee and only charged shipping fee.
- Customers can have the transfer dealer email their FFL to [BigShotsRange@gmail.com](mailto:BigShotsRange@gmail.com).

### Transfer Fees and Information:

- **Incoming:** \$50 + \$5 NICS fee (if necessary)
- **Outgoing Shipping** for Customer: Starting at \$50 + \$50 shipping
- **Private Party Transfer/Customer-to-Customer:** \$40 + \$5 NICS (if necessary)
- Customers will have 14 days (from contact) to pick up their transfer.
- **After 14 days** customer will be charged \$10 per day storage fee.
- **After 45 days** a transfer will be considered abandoned and will be absorbed into store stock with no expectation of any further compensation to the customer
- If a customer is denied when picking up the transfer, they will be responsible for the cost of shipping to return the item as well as the initial transfer fees.

Please Note: It is the responsibility of the firearm(s) owner to see that all shipments are insured sufficiently. BigShots accepts no responsibility for damage or loss for shipments that are inadequately insured.
